This memo contains a list of bills that have been proposed and approved as JBC bills/placeholders for the remainder of the legislative session.

Staff has questions for Committee members. The first question should be answered prior to closing the Long Bill.

1. Are all bills and placeholders on the below list acceptable to all members of the Committee?
 - a. The list includes three potential bills that have not yet been sent to draft – related to Proposition 130 Implementation, Accelerate DYS Bed Cap Increase and Conversion, and the FY 24-25 Reserve Requirement. Staff acknowledges not all of these will become a JBC bill.
2. If a bill type is “Proposed - non-orbital” – is it acceptable to run after the Long Bill?
3. If a bill type is “Non-orbital JBC bill” – is it acceptable to run after the Long Bill?
