


GENERAL FACTORS DRIVING THE BUDGET

2 [Rep. Taggart] On legal services, has the Department done or is the Department doing some kind of forensic audit to identify whether there are drivers of this magnitude of legal expenses so that the General Assembly could clean them up?

Response: The Department is statutorily required to use the Department of Law for attorney services and does not directly control the level of appropriations made to the Department of Law for this purpose, nor does it have statutory authority to audit Department of Law expenditures. The JBC common policy is that the Department of Law must receive 100% of any legal appropriation, regardless of the work performed. The JBC Staff analyst for this Department is in charge of funding recommendations, which prevents DORA from having any role in determining this budget.

Concerning the significant increases in the legal budget increases in the rate for legal services are a major factor. For the same work, legal rate increases have increased from \$107.60 per hour in FY 19-20 to \$142.09 per hour in FY 24-25. This can be seen in the following two tables:





As a secondary factor, new legislation passed by the General Assembly has added approximately \$2.4 million in new legal appropriations since FY 20-21. This has also contributed to the increase in legal appropriations to DORA.

Worth noting, the Department, via its initiative, has, over the years, formalized processes to expedite settlements of regulatory matters that would otherwise require legal hours spent in the Department of Law. During FY 23-24, the Division of Professions and Occupations attempted to expedite settlement within board-defined parameters of 1,150 disciplinary matters across virtually all its licensing boards, issues that would otherwise require the expenditure of legal services at much higher costs. Of these, 865 were successfully settled, avoiding an estimated 8,650 legal hours (10 hours per matter, which is conservative), which equates to \$1,229,078 in avoided legal expenditures.

3 [Sen. Bridges] Why is legal services the number one cost, and why is it increasing so much?

Response: The Department is required by statute to use the Department of Law for any legal services, and the Department's mission is to regulate over 1.1 million licensees (1/5th of the State's population). Meeting our statutory obligation to take regulatory action against a regulated entity or a licensed individual while ensuring due process can be a reasonably lengthy process requiring legal work via mediations, settlements, administrative law proceedings, and even, ultimately, litigation. For this reason, DORA represents one out of every three legal hours in the State and 35% of the Department of Law's total budget for providing legal services to state agencies. As noted above, rate increases requested by the Department of Law and approved by JBC are the primary driver of cost increases to DORA, as well as new legislation that creates new regulations or that expands or alters our regulatory authority requires the expenditure of legal resources for such things as rulemaking and enforcement.

4 [Sen. Bridges] Looking at S.B. 23-291 (table at the bottom of page 7), what are these 5.8 FTE and \$1.3 million in additional appropriations doing? How are these resources being used to carry out the purposes of the bill?

Response: SB23-291 changed many areas of the PUC's and UCA's work to achieve the bill's objective of improving energy affordability. This has resulted in several rulemakings, conducting studies, and a new pilot program to connect low-income Coloradans with bill assistance programs and hiring additional staff.

The PUC had three significant rulemakings: Proceedings No. 24R-0192G, 24R-0410E, and 24R-0168EG. However, This does not include ongoing adjudicatory work to ensure compliance with SB291 requirements—including reviewing and approving annual rate trend reports and tariff filings (including eliminating gas line extension construction allowances) and ensuring each rate case filing adheres to SB291. Rulemaking requires the combined contributions of the PUC's advisory staff, administrative law judges, administrative and legal assistants, and communications staff. The PUC was allocated 3.3 additional FTE and one temporary (one-year) FTE to support SB291's implementation.

The Commission has hired two advisors and an additional Administrative Law Judge to assist in SB291 work and increased workload across the PUC. An Affordability Program Manager was hired in 2024. The Commission is currently working to hire an additional Marketing and Communications Specialist and an additional economist—both of which will support SB291-related efforts. Lastly, the Commission has hired temporary employees to help staff heating season programs such as the Utility Bill Help program described below.

Comparably, the UCA has participated in the four significant rulemakings: 23R-0408EG Temporary Rules for Implementation, 24R-0410E Utility/ Customer Fuel Costs, 24R-0192G Financial Incentives, 24R-0168EG Prohibited Costs. These rulemakings account for Sections 2,3,4, and 5. In addition, the UCA has advocated for Section 2 and Section 3

implementation in two rate cases: 24AL-0275E (Black Hills Electric) and 24AL-0049G (Public Service Company of Colorado). The Commission has ordered outcomes consistent with the UCA's advocacy and the sponsor's expressed intent of the bill.

The UCA has posted a job announcement for three FTE (Rate/ Financial Analyst III) to conduct the activities outlined in SB23-291. The announcement closes on December 18, 2024 with an anticipated hire date of March 1, 2025. The one-time appropriation of \$23,285 for associated operating expenses was allocated and spent.

BUDGET REDUCTIONS ISSUE

[Sen. Bridges] Please address whether transfers of interest (Statewide R1) would make sense for Department cash funds. Is there a policy reason that the Department's cash funds were not included in Statewide R1?

Response: The Department is unaware of any policy reason why Department cash funds were excluded from the proposal. However, the amount of interest retained in Department cash funds is significantly smaller than the funds identified, which may be a contributing factor.

[Rep. Sirota] Please address the significant reversions that are shown in the table on page 16, especially for the PUC, the Office of Utility Consumer Advocate, the Division of Professions and Occupations, and other divisions with significant reversions.

Response: First and foremost, each dollar of DORA's budget is supported via a fee charged to a regulated individual or entity. For this reason, a critical component of the Department's fiscal management is that the <u>budget is not spent simply because it is there</u>. The Department has often reported to the Committee over the years its philosophy that there is no difference between General Funds and cash funds, with respect to the fact that what is being spent is money obtained directly from consumers and residents. It is fair to say that the need to keep fee revenue as low as possible is not a new issue for the Department but something that is continually sought each and every year.

In addition to this philosophy, several factors routinely drive reversions, and this is certainly true for DORA as well:

- New legislation has created very sharp increases in spending authority, which takes time to appear in longer-term spending patterns. During the last four legislative sessions, the General Assembly has enacted 80 separate special bills appropriating almost \$15.1 million and 81 FTE. This has affected PUC, UCA, and DPO. Additionally, ballot measures such as regulation of natural medicines have added to the Department's regulatory scope.
- Limitations on revenue have sometimes prevented spending available budget.
 For instance, a statutory cap exists on fixed utility revenue for the Public Utilities
 Commission, which required legislative remedy via SB 21-272. This has primarily affected PUC.
- Unique skill sets can make it difficult to recruit for specialized positions. New legislative mandates for entities such as PUC have required very specialized skills with it becoming necessary seek to recruit out-of-state for certain positions. This has primarily affected PUC.
- Last and most significantly, the Department does not routinely seek to create
 extra positions to consume as much budget as possible. This is visible in the
 actual FTE use reported in the budget request across fiscal years, which shows
 the Department consistently filling staff at a level that is within FTE
 appropriations. Given the nature of fee revenue to the Department,
 expenditures are not structured to hit a maximum spending target. This is true
 for all divisions across the Department.

In summary, reversions of cash fund authority result from a philosophy that does not prioritize maximum spending for its own sake. If there is interest in any further information in any particular area, the department can provide additional information as needed and will work with the JBC staff to provide it.

7 Please respond to JBC staff's additional options for General Fund relief.

Response: The Department understands and appreciates the State budget situation and remains more than open to providing the JBC Staff with any and all information to make informed recommendations on funding for FY 25-26 appropriations and beyond. The Department understands and supports the role of the JBC Staff in making tough recommendations and the spirit of the JBC Staff proposals.

The Department has two specific areas of feedback:

<u>Action to Limit Revenue Proceeds from Appropriations Change.</u> First, concerning the issue of limiting revenue, the Department is not supportive of any legal requirement or special bill to reduce revenue by a certain amount or percentage for two clear and understandable reasons:

- 1. First, existing statute already requires the Department to match revenue to spending; as such, budget reductions will automatically drive reduced revenue.
- 2. Multiple-year license cycles do not enable the Department to logistically comply with immediate revenue directives -- much of the revenue we receive this year,

for instance, comes from fees that were charged over the last several years -- in some cases back in FY 21-22. So, it is not logistically possible to comply with explicit targets or directives on revenue for a given fiscal year.

Because the General Assembly creates revenue impacts when it makes appropriations, changes to appropriations are the only way to accomplish revenue changes. The Department understands that the JBC Staff will make recommendations for appropriations levels that reflect the realities of the State budget situation.

<u>Cash Fund Transfers.</u> Second, concerning the proposal to take fund balance from the Excess Indirects Recovery Cash Fund, the Department believes this resource will likely be required (in whole or in part) in response to ongoing efforts to target small fund balances in its cash funds. As such, the Department pledges to continuously work with the JBC analyst to identify an amount that can be safely taken without undue consequence.

Response: A template has been attached that summarizes this requested information, which is compiled from the Department's most recent budget submissions and also includes expenditures and reversions which had been requested in prior years.

9 Please discuss how the Department would absorb base personal services reductions of the following amounts: 1.0 percent, 3.0 percent, and 5.0 percent. How would those reductions impact the departments operations and core mission?

Response: The Department is willing to provide analysis of information around proposed program cuts and the associated FTE impact of those reductions. As noted in the Department's JBC hearing, the Department understands and appreciates the State budget situation and remains more than open to providing the JBC Staff with any and all information to make informed recommendations on funding for FY 25-26 appropriations and beyond. The Department understands and supports the role of the JBC Staff in making tough recommendations and the spirit of the JBC Staff proposals.

With specific regard to cuts proposed at the JBC briefing, taking \$6.4 million in cuts using reverted budget authority as context -- but identified based on a 5% calculation of *total* revenue to certain cash funds in FY 24 (which fluctuates annually based on fee schedules and fund balances) -- amounts to significantly more than a '5%' reduction to actionable lines like Personal Services because the calculated amount includes a great deal of costs beyond Personal Services. For instance, including \$17 million in Legal Services and \$8 million in OIT payments alone would constitute almost 20% of the Department's budget and as such almost

20% of the Department's revenue footprint -- which means that a 5% cut based on *total* revenue if applied only to Department Personal Services is a much bigger reduction. To further elaborate on a \$6.4 million reduction, this figure would remove 100% of any possible reversion and place the Department in immediate risk of reduced regulation, separations, etc. Worth noting further, recommended cuts based on reverted budget authority do not affect cash fund revenue at DORA -- fees support division *costs* (*i.e.* actual expenditures) including central appropriations that are allocated to them, and not simply the Division's Long Bill appropriation.

Having said that, the Department is proposing via OSPB budget and revenue actions that will significantly reduce personal services (at a rate that exceeds 5%) as well as statutory fund balance transfers that will provide FY 25-26 benefit to the state budget in an amount that is equivalent to almost 100% of its General Fund appropriations. More generally speaking, reductions to personal services without corresponding reductions in statutory requirements can result in reduced capability to regulate, and as a result, reduced regulation and service to consumers. In approximate terms, a 1% reduction would roughly translate to the reduction of 7 FTE, a 3% reduction would mean the reduction of 22 FTE, and a 5% reduction would mean the reduction of 36 FTE. While it is not possible to be more specific given that such reductions might be targeted at specific areas or across-the-board, it is fair to say that the Department would pursue the following strategies to absorb such reductions were they to occur:

- Ceasing to fill vacancies as they occur;
- Not acting to fill newly appropriated positions;
- Reducing contract spending where possible;
- Managing central appropriations to shift resources to areas of urgent regulatory need;
- Identifying programs and requirements for potential legislative repeal.
- 10 Describe steps the Department is taking to reduce operating expenditures for FY 2025-26.

Response: The Executive Branch's plan for reducing operating expenditures is reflected in the November 1, 2024 budget request. With respect to the Department, two 1.0% base reductions totaling \$166k were requested for the Colorado Civil Rights Division and the Division of Insurance. Further discussions are underway with respect to recommendations made at the Department's JBC Briefing, with information forthcoming to be delivered to JBC Staff in early January concerning significant further reductions proposed by the Department. As stated above, the Department is proposing budget and revenue actions that will significantly reduce personal services (at a rate that exceeds 5%) as well as statutory fund balance transfers that will provide FY 25-26 benefit to the state budget in an amount that is equivalent to almost 80% of General Fund appropriations requested for FY 25-26.

Response: The Department of Regulatory Agencies (DORA) is dedicated to preserving the integrity of the marketplace and is committed to promoting a fair and competitive business environment in Colorado. Consumer protection is our mission -- meaning that the population served by the Department is all consumers and citizens of the State, as well as approximately 1.1 million licensee professionals and over 80,000 regulated business and institutions across over 50 regulatory programs.

Our job is to ensure that individuals and businesses who provide Colorado with professional services are doing so ethically and responsibly. Whether it's boards setting professional standards for licensing, making sure that utilities companies are charging their customers fair rates, or investigating reports of securities fraud, each and every one of the Department's employees contributes daily to ensuring that Coloradans are able to trust those who provide them with services.

Outcomes measured by the Department (which occur at the Department and Division level) are related to strategic policy initiatives in the areas of 1) protecting consumers through effective enforcement; 2) enhancing education and outreach; and 3) operational improvements to better serve stakeholders. The importance of having comprehensive measures across the scope of regulatory activities that apply from the standpoint of service to consumers *and* professionals alike cannot be overstated -- the very mission of the Department involves a balance of, and service to, these constituencies comprehensively.

Current strategies across the department for collecting customer experience data include surveys, feedback forms, post-interaction surveys, website analytics, social media monitoring, and regular evaluation of customer support interactions, while future strategies will likely focus on identifying advanced analytics and enhanced feedback collection to gain deeper insights into customer behavior and sentiment across all touchpoints.

With respect to item C, the Department makes no representation whether a fund or program should be sunset because it administers the statutory Sunset process via the Colorado Office of Research and Regulatory Reform (COPRR), and all such recommendations are made publicly to the General Assembly in accordance with statute. Independent comments or recommendations would conflict with this statutory duty of the Department.

With respect to item F, the Department sets hundreds of fees on a continual basis, and fees are statutorily required to be based on appropriations and subject to the direct and indirect costs of a program, such that revenue approximates expenditures. While it is

not possible to concisely represent a fee history, the Department is including its most recent summary of prior and estimated future fees in an attached template (this information is a snapshot in time and updated information for any particular program can be provided upon request).

With respect to item G, the following table sets forth the approximate number of licensees by cash fund, however, it should be noted that the Department's consumer protection regulatory mission applies to all Colorado consumers and citizens which is over 6 million, and is not simply a service to the licensed population:

With respect to item H, the following discussion applies. If this question and its response is being used to identify potential cash balances to transfer, the Department is communicating with the JBC analyst about the potential for that and does not recommend arbitrary transfers or reductions given the drastic and immediate financial consequences that can occur as a result of the Department's multi-year license cycles

and prior efforts to reduce fees to manage fund balance. Very often, fees are set above or below *annual* costs in order to rectify fund balance issues in accordance with statute and over a professional license cycle spanning multiple state fiscal years -- meaning that fund balances fluctuate. More specifically, an amount that appears to be 'available' in year 1 might be the only thing preventing deficit in year 2 or year 3, for instance. For this reason it is important to make inquiries about any specific fund or balance, so that the Department can share forecasting information in order that recommendations do not have unintended consequences and are explained accurately to decision makers.

Last, at the Department's JBC hearing the Department clarified that existing statute requires the Department to match revenue to spending. Multiple-year license cycles do not enable the Department to logistically comply with immediate revenue directives (in the form of a specific reduction target or percent, for instance), nor immediately replace any transferred fund balance. Because the General Assembly creates revenue impacts when it makes appropriations, changes to appropriations are the best and only way to accomplish revenue changes in a manner that comports with the timing of licensure periods.

DORA 25-26 Hearing Follow-up Questions

Committee Questions:

Sen. Amabile: RE: SB 23-290 Natural Medicine Regulation and Legalization, what is the current estimate of potential registered sellers? Will the fees be able to realistically recoup the money spent to create the market? How has this played out in Oregon?

Here is a bit of information about Oregon and their program (which as discussed below is different than the Colorado program):

Oregon Psilocybin Services (OPS) publishes a weekly report on license applications. The most recent report showed OPS has issued:

- 206 Facilitator Licenses
- 21 Service Center Licenses
- 7 Manufacturer Licenses
- 2 Laboratory Licenses
- 418 Worker Permits
- 24 Training Programs have received OPS curriculum approval

For DPO, there is an estimate of facilitators of 125 facilitators in the first year and 250 in the second year in the fiscal note (SB23-290). The estimated volume for training programs in the fiscal note (SB24-198) was anticipated to be relatively low, and it's worth noting that the analyst estimated there would be a single training center license in year one. To date, DPO has approved 11 training facilities and is reviewing 5 additional applications. This revenue from these programs will contribute to the sustainability of the overall program. With respect to recouping money, as we mentioned at the hearing, regulatory costs must necessarily be adjusted to reflect the financial realities of revenue for a new and unknown population such as this program, and we do not presently expect to be requesting any form of subsidy due to insufficient revenue.

There are notable discrepancies between the Oregon law and what Colorado voters passed with Prop 122, however. Oregon's OPS has oversight of all of the above listed licenses, approvals, and permits. In contrast, the Colorado Department of Revenue (DOR) and DORA/DPO share the responsibility for the program in Colorado. DPO has oversight of facilitators and training programs while DOR licenses Healing Centers and has responsibility for the regulation of the product. Our understanding is that Oregon did have some initial funding challenges they needed to address, but the regulatory structure is different and is not something we anticipate within DORA/DPO.

Sen. Kirkmeyer/Amabile: Please submit an update of the current and estimated ongoing costs associated with litigation re: SB21-175 Prescription Drug Affordability Board. Please update on what drugs have begun the process and what drugs are upcoming.

Amgen filed suit against the PDAB, PDAB Members, Commissioner Conway, and AG Weiser in federal district court. To date, the total cost of defending the litigation against these parties has been \$153,979.78. Those costs have been primarily associated with preparing and arguing on motions for summary judgment; the motions were argued in October 2024. At this time, we are unable to estimate the ongoing costs with the litigation as those costs are dependent on the court's decision on the summary judgment motions.

Regarding the progress of the PDAB Board's drug review, in 2023, the Board approved a list of 604 drugs that met the thresholds outlined in the law and therefore were eligible for an affordability review. The Board determined which of the 604 drugs to select for affordability review by applying 19 data requirements (referred to as selection criteria) listed in the statute (10-16-1406(2), C.R.S.) to those 604 drugs. After extensive public comment, input from the Advisory Council, and with the support of two experts from the Skaggs School of Pharmacy who led the Board in a multicriteria decision making exercise to rank and weight selection, the Board narrowed the 604 drugs by setting thresholds that aligned with their priorities of number of patients impacted, change in WAC, and patient spending.

On August 4, 2023, the Board adopted resolutions to select the following five (5) drugs for affordability review:

- Trikafta
- Genvoya
- Enbrel
- Stelara
- Cosentyx

The affordability reviews for each of these drugs has been completed. Each affordability review contained 15 statutorily set criteria for the Board to consider in determining whether the use of a prescription drug was unaffordable to Colorado consumers. Each review involved extensive data analysis as well as input from patients, caregivers, providers, consumer groups, individuals with scientific and medical training, industry, and other experts. Feedback was obtained through surveys as well as at 14 drug specific stakeholder meetings. Those reports run anywhere from 200 pages (Genvoya) to almost 600 pages (Trikafta).

Although there are currently 7 states with PDABs, Colorado's PDAB is the first PDAB in the country to complete any affordability reviews.

Based on the Board's review of the reports and considering feedback from the community at large over multiple Board meetings, the Board voted that two drugs, Trikafta and Genvoya, were not unaffordable for Coloradans. That concluded the process for those drugs.

Again, based on the Board's review of the reports and considering feedback from the community at large over multiple Board meetings, the Board voted that three drugs, Enbrel, Stelara, and Cosentyx, were unaffordable for Coloradans.

As a result of the Board's decisions, Enbrel, Stelara, and Cosentyx are eligible for an upper payment limit (UPL), which is established via the Board's rulemaking process. The Board has said it plans to hold at least three UPL rulemaking hearings for each prescription drug. Enbrel's first UPL rulemaking hearing will begin in January 2025; it is anticipated that the rulemaking hearings for Stelara and Cosentyx will begin later in 2025.

Board staff anticipate that the number of prescription drugs that will be eligible for the next round of affordability reviews will likely be in the 600 range, similar to the first round of affordability reviews.
