Sunset and Sunrise Status Update

The Colorado Office of Policy Research and Regulatory Reform (COPRRR) provides the General Assembly with sunset and sunrise reviews based on specific statutory criteria.

Given our statutory charge to balance recommending the minimal regulatory burden while ensuring consumer protection, sunset reviews have recommended, when appropriate, eliminating dozens of regulatory boards, committees, or government functions since 1977. Ultimately, the Legislature determines which regulations should be created or continued. Since 2019, Sunset Reviews have recommended sunset at least 15 times, but in some instances, the General Assembly has rejected or is currently rejecting those recommendations. Also, via the sunrise review process, there are three recent instances in which we recommended against creating new regulations (see Table 1), and the General Assembly is in the process of rejecting those recommendations as well

Below are three tables: Table 1. 2025 pending legislation, where the COPRRR recommended not to regulate a specific occupation; however, legislation was introduced to regulate it; Table 2. 2025 potential legislation, where an advisory board was recommended to sunset, but a bill to continue may be introduced; Table 3 includes historical Sunset recommendations, but the General Assembly passed regulation.

Sunrises–2025 Legislative Session (pending legislation): Recommendation to not regulate, but the General Assembly is currently running legislation to regulate Table 1
